Drainage and dykes approved by EA, Buildings are near flood plain with future proofing Effect on local farmers of the extra water, on their existing drainage.

More people involved 600 for events and 49 cabins, noise, transport, Events sewage, etc.

Lack of communication with neighbours, one is feet away from toilets etc.

Access on A614, increase in cars, delivery lorries and difficulties in turning right.

Security to local properties from holiday makers and their safety near A614.
